



## Commercial Vehicle Driving Scholarship Application

Student scholarships are awarded through application to the Bradford-Union Technical Center and require approval from the scholarship committee. Scholarships will be limited to funds available. **The scholarship may cover tuition, books, kit and/or lab fees. The scholarship can be revoked due to lack of attendance, unacceptable academic performance, inappropriate behavior, or withdrawal from the program. Prior to completing a scholarship application, you must first submit a 2016-2017 FAFSA application.** Please answer all questions thoroughly. The scholarship committee will consider all elements, including financial situations, in determining the award amount.

### Purpose

The purpose of the BUTC Commercial Vehicle Driving Scholarship is to provide financial assistance to qualified applicants who have demonstrated career interest in commercial vehicle driving.

### Awards

One scholarship award up to \$1500 is available for the Commercial Vehicle Driving Program. Awards must be used within current school year of notification of receipt of scholarship and awards are non-transferable.

### Eligibility

1. Applicants must be eligible for the CVD Program and be 18 years of age or older.
2. Applicants must be U.S. citizens.
3. Must meet all minimum requirements for entrance into the Commercial Vehicle Driving program. (Find enrollment criteria at [www.BUTC.edu](http://www.BUTC.edu))
4. Applicants must complete their FAFSA Application. Your 2016-2017 FAFSA will be based on your 2015 income tax information and therefore, if your financial situation has changed since 2015 to the present, please explain.

### Selection Criteria

1. Demonstrated or expressed interest in Commercial Vehicle Driving.
2. Student essay.
3. Financial needs based on FAFSA Application.

## **Application Requirements**

To be considered for the scholarship award, applications must be completed and returned to BUTC at least 10 business days prior to the start of the next Commercial Vehicle Driving Class.

The application must include:

1. A completed scholarship application form. Only completed scholarship applications forms will be considered.
2. A completed CVD application form. Only completed CVD applications will be considered. The \$100.00 deposit for the CVD program must be paid prior to receiving any scholarship funds.
3. A one page typed (< 300 words) essay stating the applicant's qualifications; educational and career goals; and nature of the financial need. The essay will be evaluated on content and not on grammar.
4. Attach a copy of your latest income tax return (if IRS Retrieval was not used for FAFSA)
5. Complete FAFSA application ([www.FAFSA.ed.gov](http://www.FAFSA.ed.gov))

**The above items must be received at least 10 business days prior to the start of the next Commercial Vehicle Driving class before the application will be considered. Partial scholarships will not be awarded.
